OFFICIAL RULES

Sponsored by Kraddick Fund for Kids d/b/a Kidd's Kids and YEA Networks, its subsidiaries, and affiliated companies (herein "Sponsor").

OPEN ONLY TO INDIVIDUALS WHO ARE LEGAL RESIDENTS OF, AND CURRENTLY RESIDING WITHIN THE FORTY-EIGHT (48) CONTIGUOUS UNITED STATES AND THE DISTRICT OF COLUMBIA ("D.C.") (EXCLUDING NEW YORK AND FLORIDA), WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE OR OLDER AT THE TIME OF ENTRY (NINETEEN (19) OR OLDER IF A RESIDENT OF ALABAMA OR NEBRASKA). WINNERS OF THE SOUTHWEST AIRLINES PLANE TICKETS IN THE FIRST PRIZES LISTED BELOW IN 5c MUST BE AT LEAST NINETEEN (19) YEARS OLD. A VALID EMAIL ADDRESS AND INTERNET ACCESS IS REQUIRED FOR ENTRY. - 1. Sweepstakes Period:** Kidd's Kids "Car Contest 2026" Sweepstakes ("Sweepstakes") begins on March 30, 2026 at 7:00am CDT and ends on June 4, 2026 at 11:59pm CDT ("Sweepstakes Period"). Sponsor is the official timekeeper for the Sweepstakes.
- 2. Eligibility:** The Sweepstakes is open only to legal residents of 48 contiguous United States and D.C. (except New York and Florida) who are currently residing therein, and who are at least eighteen (18) years of age or older at the time of entry (nineteen (19) or older if a resident of Alabama or Nebraska). Employees, officers and directors of Kidd's Kids, YEA Networks, Southwest Airlines Co., their respective parent companies, affiliates, subsidiaries, distributors, suppliers and advertising and promotion agencies associated with the Sweepstakes, and members of the immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are NOT eligible to participate in the Sweepstakes. Non-eligibility or non-compliance with any of these Official Rules may result in disqualification. Sweepstakes is void outside of the 48 contiguous United States/D.C. and wherever prohibited by law. The sweepstakes is subject to United States Law.
- 3. How to Enter:** There are two (2) ways to enter. During the Sweepstakes Period, go to www.carcontest2026.com and purchase an entry; for every \$25 purchase the participant will receive 50 entries, for every \$50 purchase the participant will receive 125 entries, for every \$100 purchase the participant will receive 300 entries, for every \$150 purchase the participant will receive 525, for every \$250 purchase the participant will receive 1000

entries. To receive one (1) entry without making a purchase, visit <https://www.kiddnation.com/kidds-kids-car-contest-free-entry/> and enter your full name, address, city, state, ZIP code, email address, and phone number before June 4, 2026 at 11:59pm CDT. **Limit one (1) free entry per person, per Sweepstakes period.** No robotic, programmed, script, macro, or other automated entries (collectively “Automated Entries”). Automated entries or entries that have been tampered with will result in disqualification of all such entries. Sponsor and respective directors, officers, agents, and employees are not responsible for lost, late, misdirected, or incomplete entries. Incomplete entries will not be acknowledged and will not be included in the Sweepstakes drawing. All entries submitted become property of Sponsor. Submission of an entry is subject to, and all entrants must comply with, all policies, terms and conditions set forth in these Official Rules. Proof of submission does not constitute proof of receipt. Only the person associated with the entry may be entitled to a prize. In the event of a dispute as to who entered, the name of the “authorized account holder” associated with the email account used for entry will be deemed to be the entrant as long as such person is eligible and in compliance with these Official Rules. The authorized account holder of the email address is defined as the natural person who is assigned to the email address by an Internet access provider, online service provider, or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Entries must be completed by 11:59 pm CST on June 4, 2026 to count toward entry into the Sweepstakes drawing. Any entry that does not comply with these requirements, in the sole opinion of the Sponsor, may be disqualified.

- 4. How to Win:** To be eligible for the First Prize Sweepstakes drawing, an eligible entry must be received during the Sweepstakes Period. Odds of winning the Sweepstakes prize will depend on the total number of eligible entries received during the period. **First Prize Drawing Periods:** Prize 1: March 30 – April 8, 2026. ONE winner (unless specified in 5c) will be selected during each prize period for a total of six (6) prizes awarded. Winners of a First Prize are still eligible to win the Grand Prize.

Grand Prize: To be eligible for the Grand Prize Sweepstakes drawing, an eligible entry must be received during the entire Sweepstakes Period. Odds of winning the Sweepstakes prize will depend on the total number of eligible entries received. Kidd’s Kids will randomly select three (3) finalists from all eligible entries to compete as finalists for the Grand Prize and attempt to contact them via **EMAIL** and/or **PHONE** on or after June 5, 2026. If a finalist lives more than 200 miles from San Antonio, the Sponsor will fly them from the closest major metropolitan airport serviced by Southwest Airlines and provide hotel accommodations for the night of June 18, 2026. If a finalist lives between 30 and 199 miles from San Antonio, TX, Sponsor will provide hotel accommodations for the night of June 18, 2026.
